Healthy Collaborations

Child Care Opportunities Resource Development Center has several collaborative projects with the Healthy Maine Partnerships (HMPs) in Hancock and Washington counties. These projects are focused on supporting child care providers in maintaining safe and healthy environments for children and being a resource for the children/families they serve.

Through a Lead Poison Prevention initiative of the regional HMPs, Child Care Opportunities is offering Eco Healthy Child Care training in each of the HMP regions in Hancock and Washington counties. This training has been available to child care providers through the RDC. Now through our collaboration this training is also open to families who would like to learn the simple, cost effective ways to make the home environment more 'eco friendly'. Check our training calendar or call Joy to inquire about an Eco Healthy Child Care training near you. Providers are encouraged to invite other members of the community and families of children in their care to these trainings. This initiative is being coordinated through Healthy Peninsula Program, the HMP in Blue Hill.

The district tobacco coordinator serving our region is Sally Christ. Sally works out of Healthy Peninsula and offers trainings throughout the district on smoking cessation and the dangers of second hand smoke. When these trainings are offered to providers, Child Care Opportunities RDC works closely with Sally to coordinate and publicize the trainings.

Another example of collaboration with an HMP is an opportunity for Child Care Opportunities to offer several 'I Am Moving, I Am Learning' workshops at no cost to those attending. This is part of a grant being coordinated by the HMP in Bar Harbor, Healthy Acadia.

The Bucksport Bay Healthy Communities Coalition has worked closely with Child Care Opportunities RDC on several projects. Currently, BBHCC and the RDC, through a grant from United Way of Eastern Maine, is supporting and facilitating a monthly meeting of Bucksport area child care providers. It is an opportunity for providers to meet, share and receive some training. In addition, this coalition puts on a children's fair each spring.

The HMPs are a great resource for information for all ages and I encourage you to explore your local Healthy Maine Partnership. (See pg. 3 ~ Healthy Maine Partnerships)

"Strive For Five!"

In October, Child Care Opportunities RDC hosted four training sessions with Michel Lahti, PhD from the University of Southern Maine. These sessions were held in both Hancock and Washington counties. The training sessions were designed to educate providers about Michel's role in evaluating the Quality for ME Rating System, to help providers to understand the scoring and interpretation of the Environmental Rating Scales used during on-site observations of programs and to address specific questions from providers. Here are some of the things we learned.

Participation in the on-site observation is voluntary and providers are picked at random. The results of the rating scales are used for research purposes, and do not impact a program's quality rating. However, those who participate in the observations can use the feedback they receive as a framework for improvement if they choose.

The rating scale used for on-site observation is determined by the setting and would be either the Infant/Toddler Environmental Rating Scale, the Early Childhood Environmental Rating Scale (for center-based programs), or the Family Child Care Environmental Rating Scale. The rating scales are research-based, have been used all over the world, and are considered very reliable tools. Each scale is broken down into categories such as "Space and Furnishings" and "Personal Care Routines." Each category is further broken down into observable indicators and can be scored on a range from one to seven. There are three areas which are always measured across all categories and indicators: health & safety, relationships & interactions, and opportunities to learn. Due to the design of the rating scales, it can be difficult for any program to score a seven. Michel's advice for those participating in the training sessions was to "Strive for a Five!"

If you would like to learn more about the Environmental Rating Scales, the RDC has copies of the tools available for providers to view. In addition, we will be offering more training sessions on how the tools are scored and interpreted, and on specific aspects of quality. HEALTHY MAINE PARTNERSHIPS



Are you looking for resources to help the children in your care be more physically active with their families? Would you like help providing information to parents

about secondhand smoke or lead poisoning? Do you have an idea for a project that might improve the health of your community? Your area Healthy Maine Partnership is a great place to start. Local Healthy Maine Partnerships (HMPs) are part of a statewide system of public health organizations that bring people and resources together to improve the health and well being of the communities they serve. The prevention, advocacy, and education work they do helps people become healthier and gives everyone access to the state's public health resources.

Hancock and Washington counties have six HMPs – Bucksport Bay Healthy Communities Coalition, Healthy Peninsula, Union River Healthy Communities, Healthy Acadia, Washington County One Community, and St. Croix Healthy Communities. They partner with schools, health care providers, and other community organizations to work on a variety of initiatives addressing physical activity, nutrition, tobacco, substance abuse, chronic disease prevention and self-management, and community development. For example, Healthy Peninsula has created a trail guide and letterboxing project in the Blue Hill Peninsula area to encourage families to be active together. They are working with schools and preschools to provide additional nutrition education and to develop school gardens. They are working with the RDC to promote lead poisoning prevention efforts with childcare providers and families of young children. The district tobacco coordinator, Sally Christ, works with all of the Hancock and Washington County HMPs to provide education and resources that help prevent tobacco use, reduce children's exposure to secondhand smoke, and assist people who are ready to quit smoking.

Visit the website of your area's Healthy Maine Partnership (listed below) and see what projects they are working on in your community. Contact your Healthy Maine Partnership if you want health promotion materials to provide to the families of the children in your care. They have access to resources in all of our program areas, as well as up-to-date information about public health issues such as flu prevention and vaccination. Healthy Maine Partnerships are well positioned to help with grassroots efforts to improve the health of our communities. Maine's Infant Toddler Credentials

There is a nationwide movement to professionalize infant/toddler care. This is an effort to ensure that babies are given the highest quality care possible. Research shows that caregivers' professional development is key to ensuring that quality. Maine has worked with the Zero to Three Learning Community to develop a 3 tiered infant toddler Credentialing System to ensure that training is available for caregivers who do not have college experience, as well as for those who do.

Infant Toddler Credential 1: (ITC 1) No college necessary. The four trainings necessary can be taken through any of the Child Care Resource Development Centers. Following the completion of these trainings, a portfolio is developed by the applicant and reviewed by Maine Roads to Quality to determine if competencies have been met.

Infant Toddler Credential 2 is coming!

1st Class Available January 2010

Early Care Professionals who have **completed their Associate's degree** in Early Childhood Education or a closely related field and have completed the following courses **or equivalents**:

- * Introduction to Early Childhood Education (3 credits)
- * Observing and Recording Children's Behavior (3 credits)
- * Infants and Toddlers (3 credits)

The first advanced course will be **offered state-wide over ITV** beginning January 25 through May 10, 2010 from 4:00-6:45 p.m.

NEW LEGISLATION BENEFITS FAMILY CHILD CARE PROVIDERS

One of the hurdles that Family Child Care providers have had to face is the difficulty of finding or maintaining home owners insurance once they start their child care business. There is now some relief to that barrier to running your child care business.

Legislation passed last May forbids the insurer from canceling or refusing insurance to cover the primary residence just because there is a child care business at the home. The child care business must be covered by a separate insurance coverage for business liability.

New Maine Roads To Quality Scholarship Information!



Maine Roads to Quality has received funds from the American Recovery and Reinvestment Act (ARRA), also known as “stimulus funding.” These funds will allow us to offer more scholarship opportunities than ever before. MRTQ has also revised the income guidelines to include only the student’s income. Students must earn less than \$40,000 per year. Scholarships for college classes may be used for tuition, fees, and books. The funding levels for 2009-2010 are: Associate’s-level classes: \$100/credit; Bachelor’s-level classes: \$219/credit; Master’s-level classes: \$294/credit; CDA Scholarships may be awarded for the \$325 CDA Assessment Fee, \$150 for advising services, and up to \$300/course for 3 courses for credit-bearing coursework.

Scholarship applications will be reviewed on a rolling basis each month. Applications received after the 10th of the month will be reviewed the following month. A certain portion of the scholarship funding through ARRA will be targeted to providers taking coursework regarding the care of infants and toddlers. Students must be Maine residents and attending a college or university based in Maine. This includes the Wheelock College Bachelor’s and Master’s degree programs offered in Maine. THE FLU AND YOU!

The production of H1N1 (swine flu) vaccine this fall has delayed shipments of seasonal flu vaccine. Soon there will be plenty of both to go around, but until then the following groups are first in line to be immunized once vaccine is available.

H1N1 Flu

- Pregnant Women-Persons who live with infants up to 6 months (parents, siblings)
- Children and young adults 6 months - 24 years-Persons 25-64 with medical conditions (asthma, diabetes, heart disease)
- Healthcare workers and Emergency Medical Staff

Seasonal Flu

- Persons 65 years and older-Children less than 2 years old-People of any age with a chronic medical condition (asthma, lung disease, heart disease)
- Healthcare workers

Follow these basic tips for reducing the spread of germs and staying healthy:

1. Cover your coughs and sneezes with a tissue or sleeve.
2. Wash your hands often with soap and water.
3. Avoid touching your eyes, nose and mouth.
4. Avoid close contact with people who are sick.
5. Stay home if you are sick.
